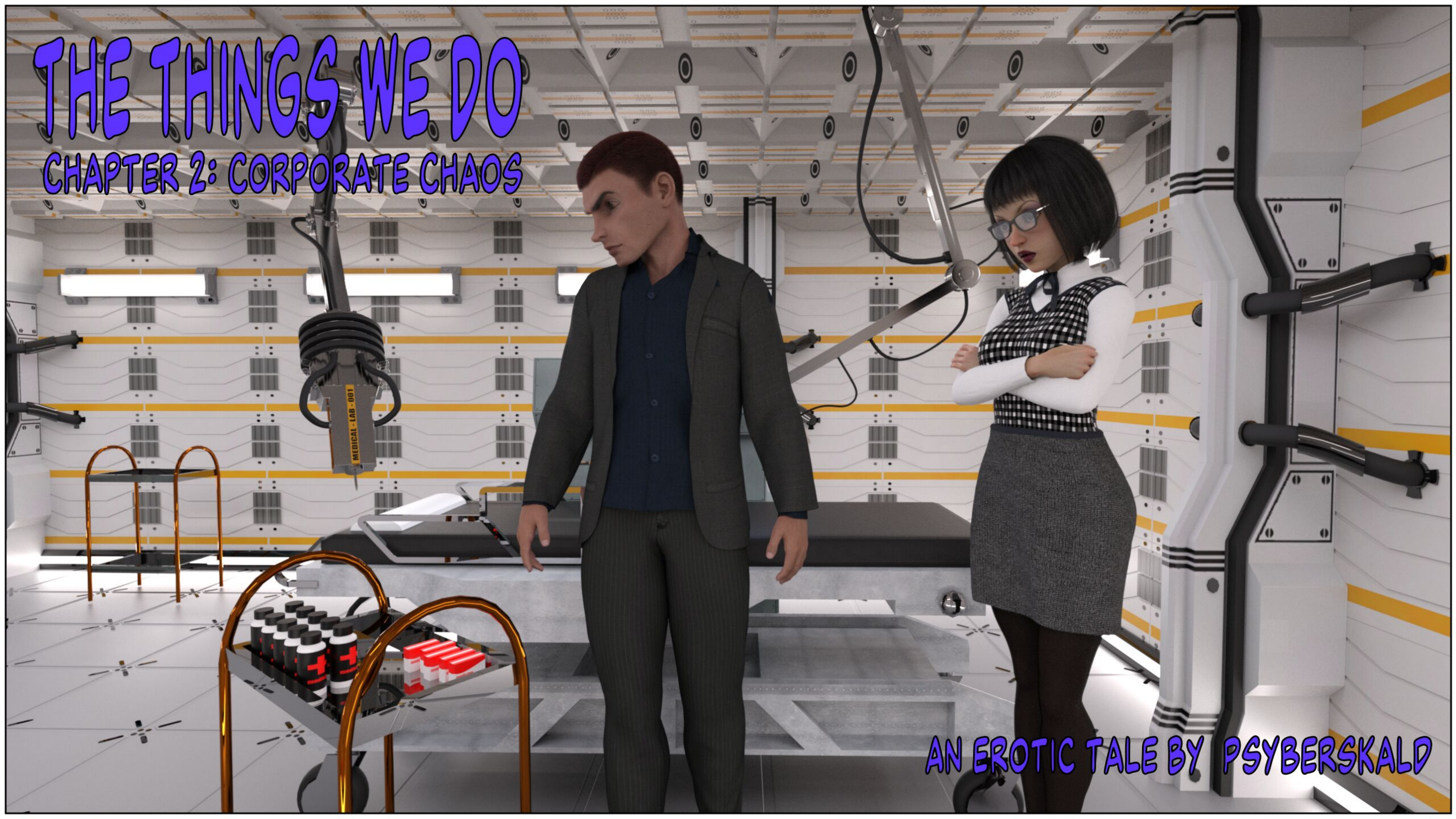

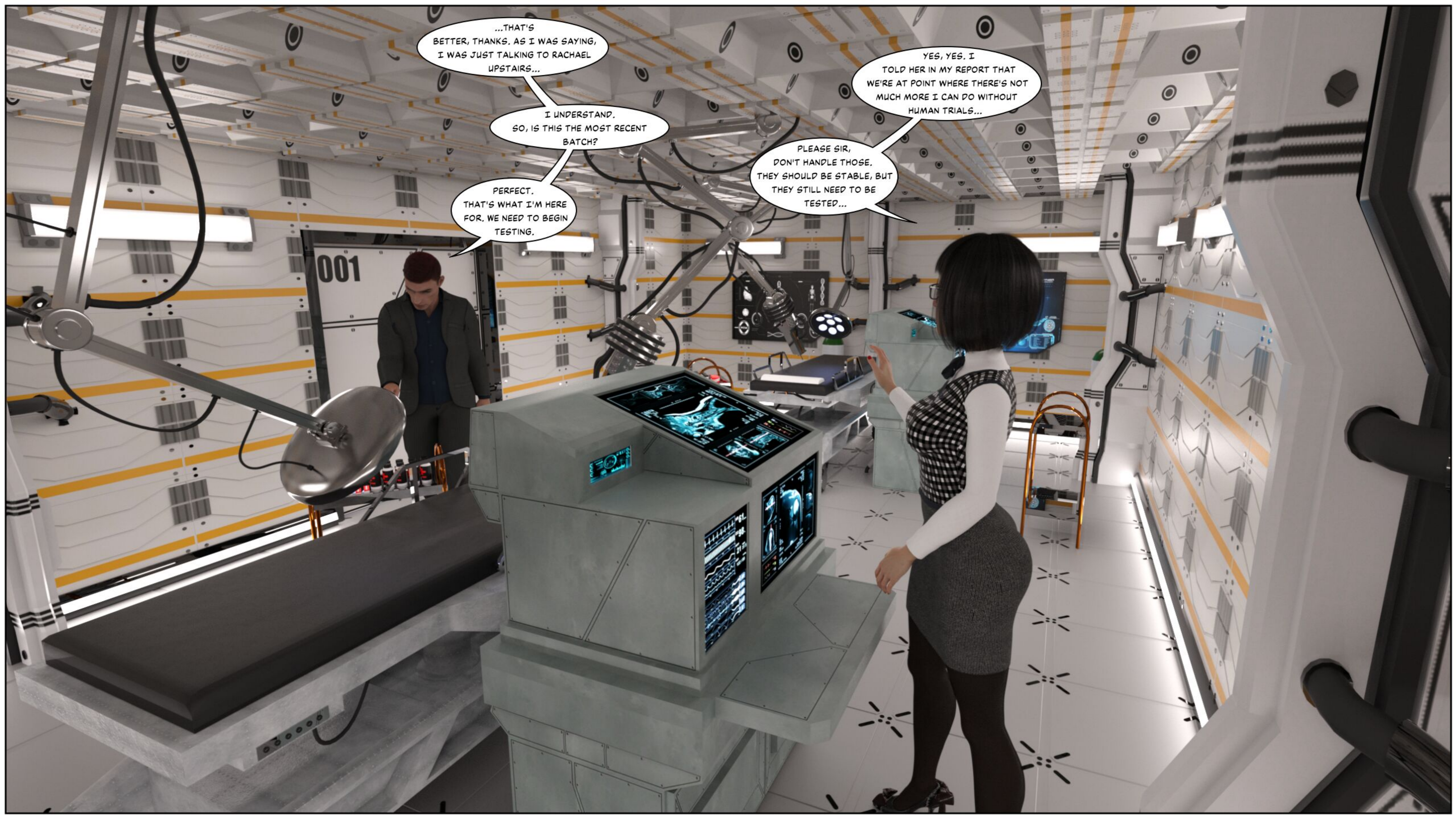
...THAT'S BETTER, THANKS. AS I WAS SAYING, I WAS JUST TALKING TO RACHAEL UPSTAIRS...

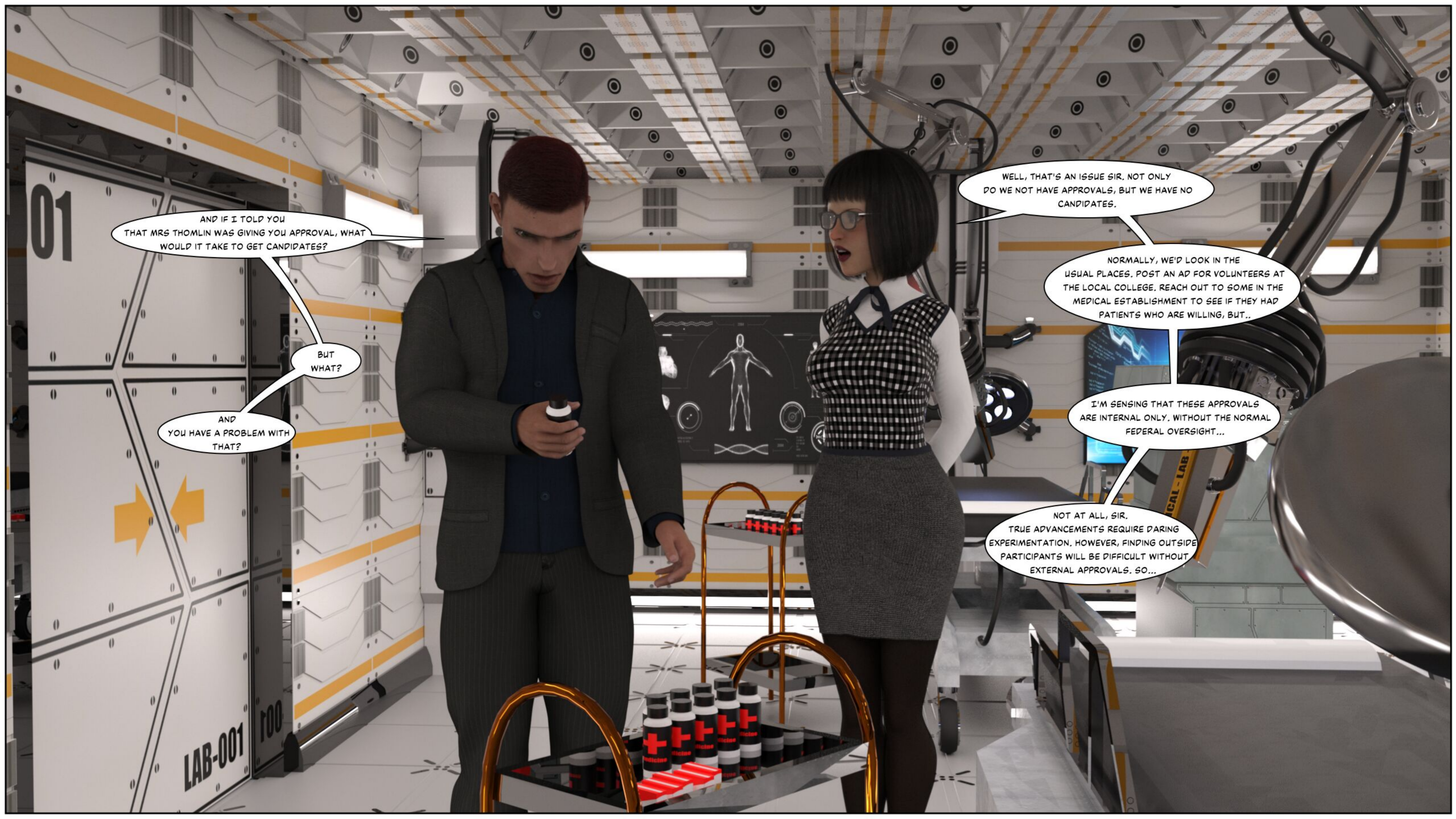
I UNDERSTAND. SO, IS THIS THE MOST RECENT BATCH?

I CAN'T BELIEVE IT'S COME TO THIS... BUT WHAT CHOICE DO WE HAVE?

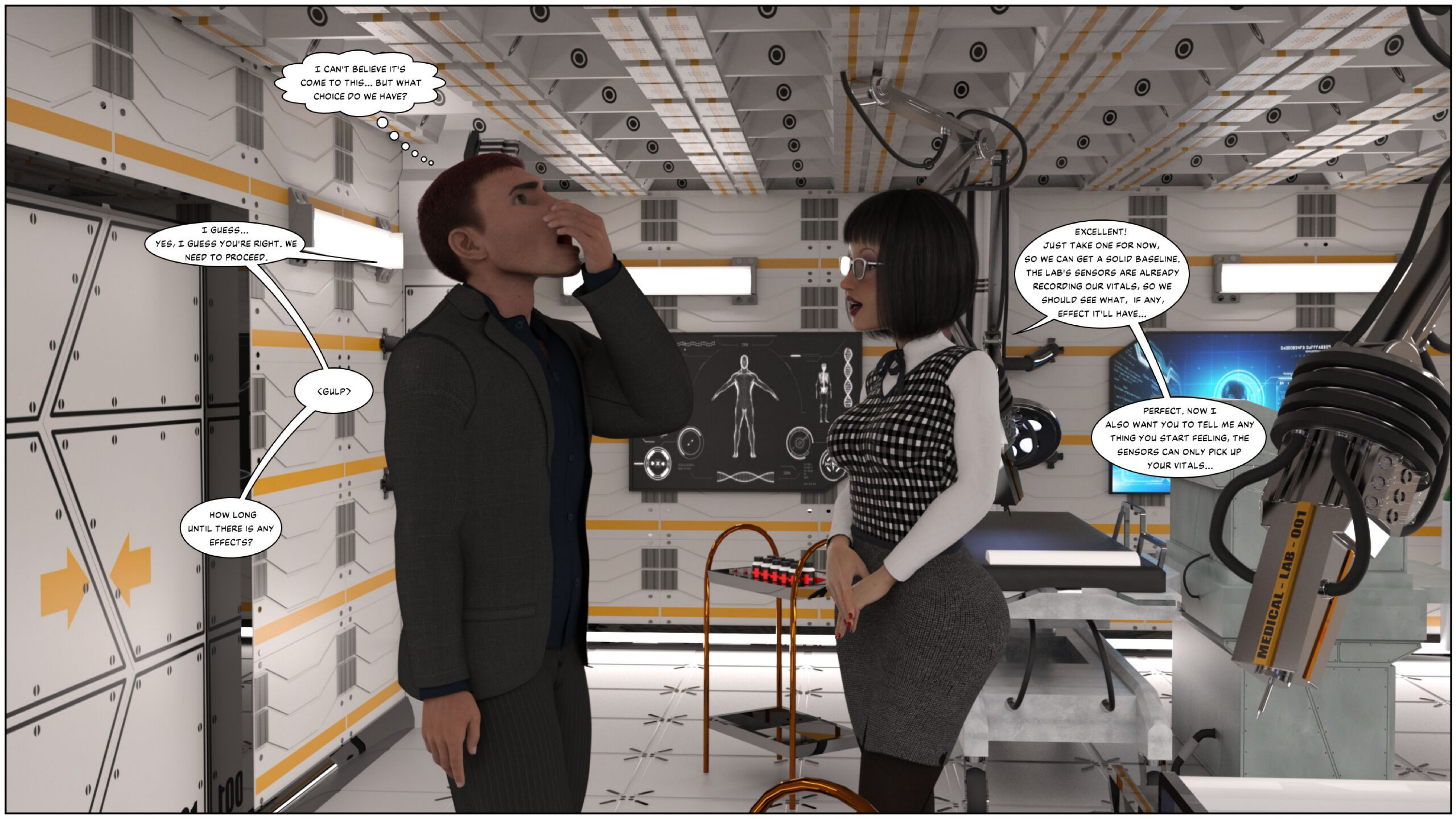
I GUESS... YES, I GUESS YOU'RE RIGHT. WE NEED TO PROCEED.
